Functions of the Academic Council include;

- Scrutinize and approve the proposals with or without modification of the Boards of Studies with regard to courses of study, academic regulations, curricula, syllabi and modifications thereof, instructional and evaluation arrangements, methods, procedures relevant thereto etc., provided that where the Academic Council differs on any proposal, it shall have the right to return the matter for reconsideration to the Board of Studies concerned or reject it, after giving reasons to do so.
- Make regulations regarding the admission of students to different programmes of study in the college keeping in view the policy of the Government.
- Make regulations for sports, extra-curricular activities, and proper maintenance and functioning of the playgrounds and hostels.
- Recommend to the Governing Body proposals for institution of new programmes of study.
- Recommend to the Governing Body institution of scholarships, studentships, fellowships and medals, and to frame regulations for the award of the same.
- Advise the Governing Body on suggestions(s) pertaining to academic affairs made by
- Perform such other functions as may be assigned by the Governing Body.

Functioning of the Board of Examiners:

The functions of the Board of Examiners include;

1. Preparation of database of the Examiners: BOE in consultation with all the members shall identify the faculty members from PG Department of Management from various Institutions / Universities - subject wise and specialization wise to have a comprehensive database of Examiners.
2. BOE should identify the Examiners from the database and send invitation to the identified examiners for question paper setting for Semester End Examination (SEE).
3. 5. BOE Should meet periodically to review the Examination Process and suggest suitable measures for overall development of the Examination Centre.

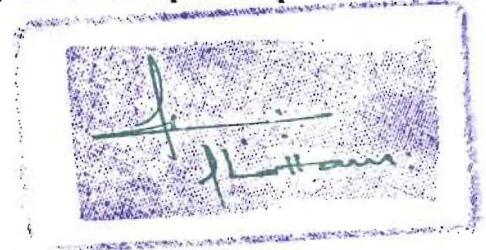
