Introduction: Financial planning is the process of estimating financial needs of a person and implementing a comprehensive plan to meet those financial needs during his or her lifetime through investment. For instance, birth of a child, education, purchasing house, marriage, meeting emergency situations like an illness, to meet the impact of an accident, death, or natural calamities like flood, etc.

Objectives:

- * Develop Financial Goals
- * Determine Current Financial Situation
- * Identify specific financial goals
- * Classify goals into Short-term, Medium term or Long term
- * Decide upon asset-allocation
- * Choose the right investments with diversification (within asset classes)
- * Three pillars of investment - The investment decision by an individual is influenced by **safety, liquidity and return.**

Some of the key features taught :

Returns from Investment: Regular Income:

- **Equity Investment:** You get dividend when you buy and hold equity shares of a company and units of equity mutual fund.
- **Fixed Income Investment:** In debt securities, you receive fixed interest on interest bearing Investments
- * **Capital Appreciation:** When the value of initial investment increases over a period of time and the investor benefits by selling part or whole of the investment at the increased value, it is called Capital Appreciation.

Primary Market:

When a company publicly issues new stocks and bonds for the first time, it does so in the primary market. In many cases, this takes the form of an initial public offer (IPO). SEBI examines the prospectus issued to the public for subscription of shares to see that it meets with the requirements of the SEBI Regulations. Companies issuing securities via the primary market hire merchant bankers who, on behalf of the company, prepare the prospectus and ensure related compliance for the issue of shares viz. finalization of allotment process, listing of shares in the stock exchanges, etc.

Secondary Market:

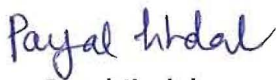
Secondary market is the market where securities are traded after the company has issued the stocks and bonds in the primary market. The shares are listed and traded on the stock exchanges which facilitates the buying and selling of stocks in the secondary market. Major SEBI recognized stock exchanges in India are BSE Ltd. (formerly Bombay Stock Exchange Ltd.) and the National Stock Exchange of India Ltd. (NSE).

Insurance:

Insurance allows individuals, businesses and other entities to protect, primarily used to manage the risk of an uncertain future loss. themselves against significant potential losses and financial hardship at a reasonably affordable cost. Insurance is a form of risk management

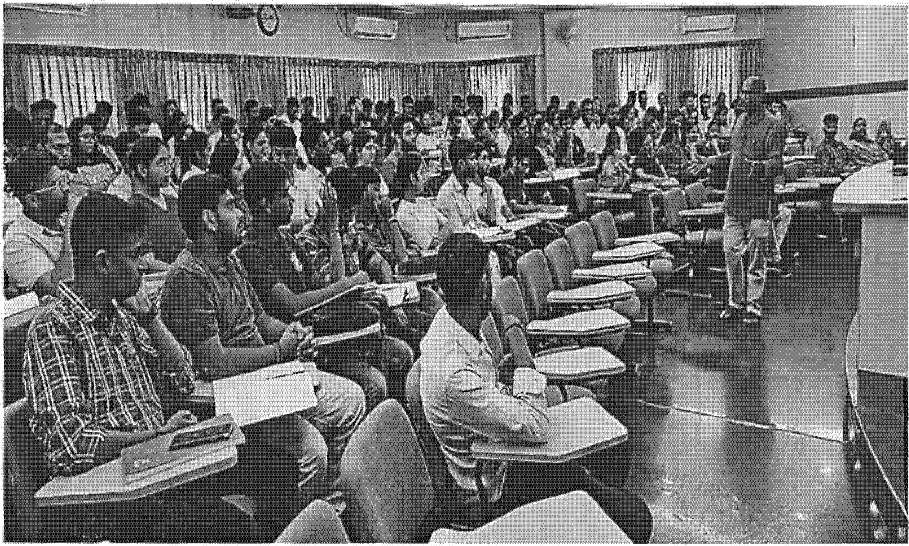
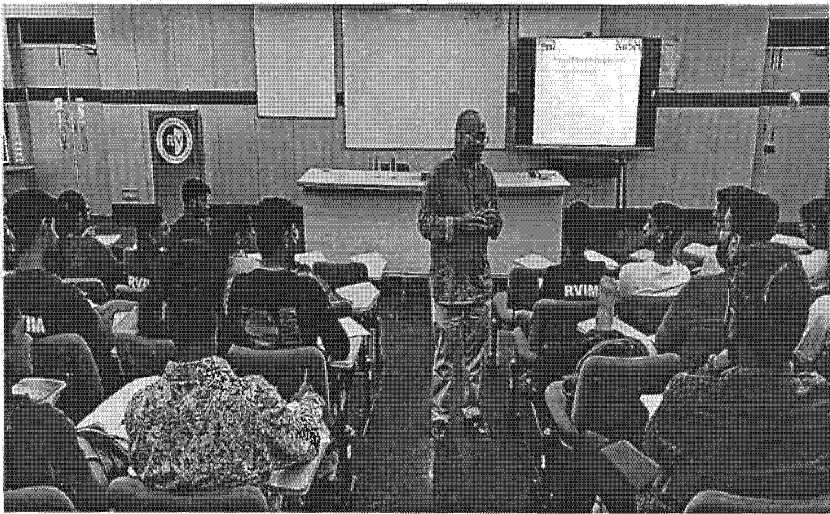
