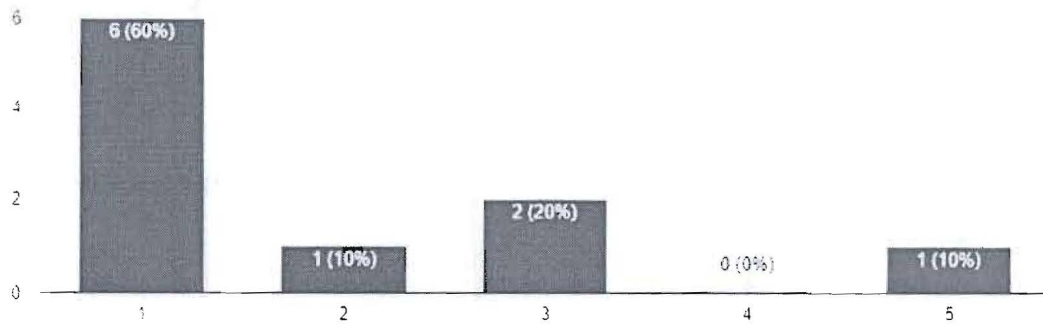

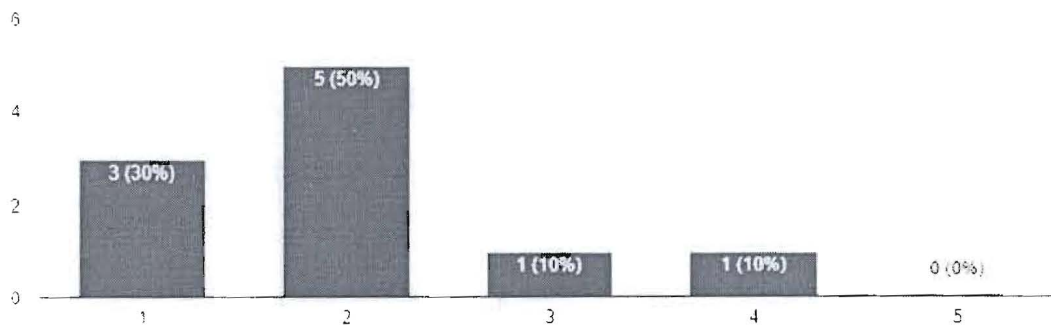


60% of teachers strongly agree that the syllabus is designed keeping in mind the needs of the industry.

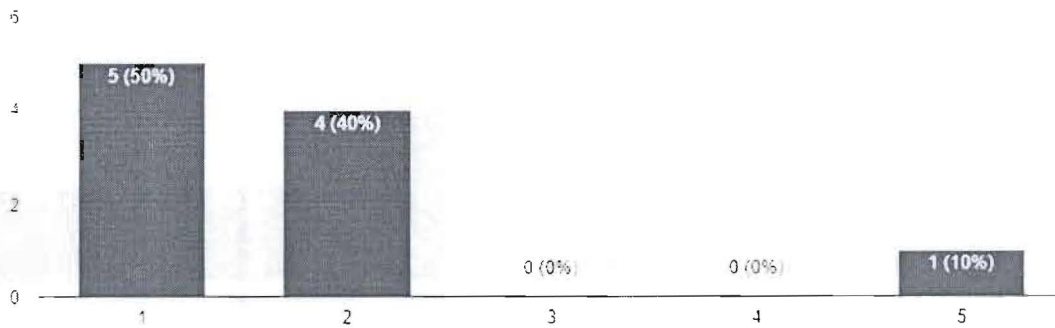

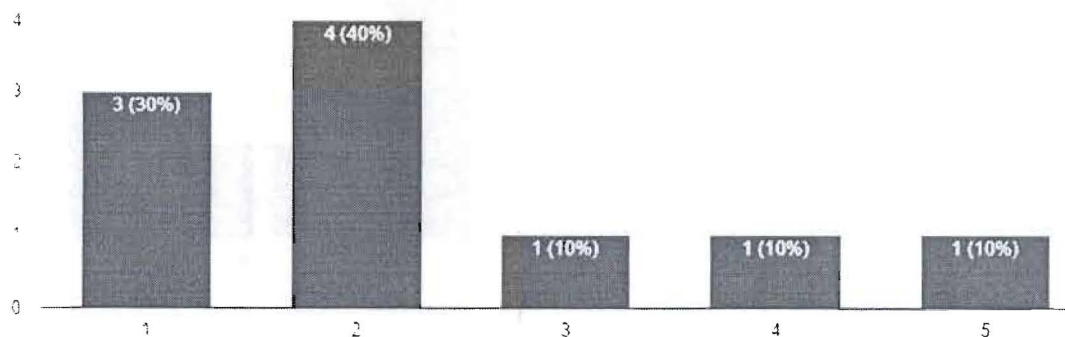

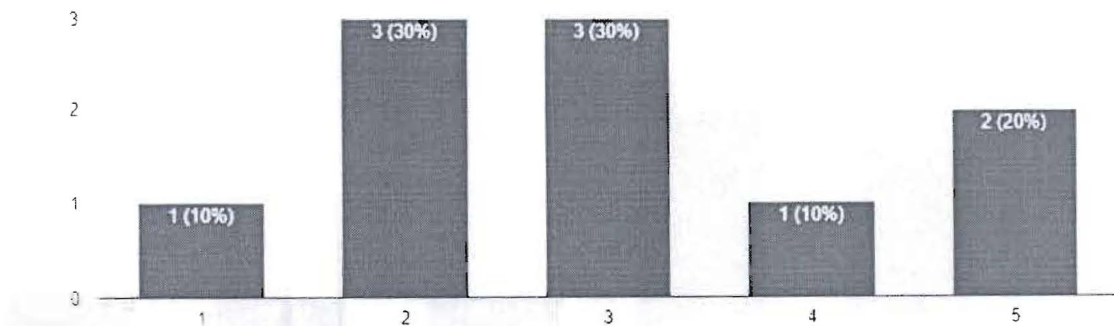

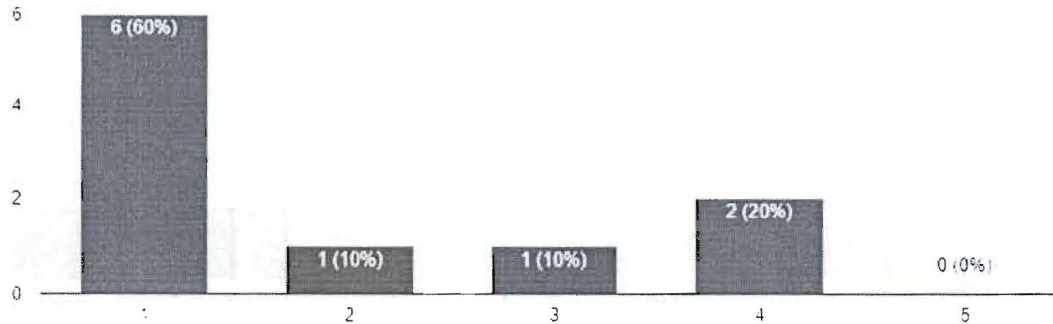

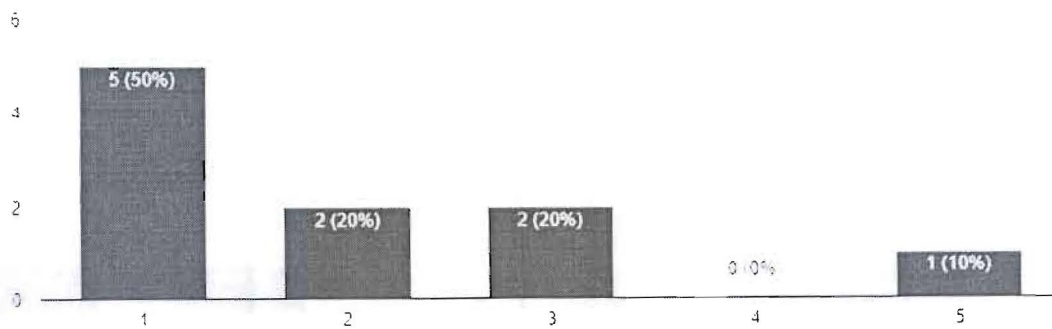
