1. It is clearly understood that the period of this Internship shall be for a period of two months commencing from 14/11/2024 ; This Internship automatically comes to an end after the expiry of two months from date of your reporting for duty without any further notice of assigning any reasons whatsoever.
2. You will be paid a monthly stipend of Rs.10,000/- PM (Rupees Ten Thousand only) wef 1st December 2024
3. You will be working on all week days (Monday to Saturday) as per the working hours requirement of the department ; You would be reporting to the Director - SSNCCPR. You are not eligible for any leaves other than weekly offs.
4. Management can reduce the period of Internship to any period less than two months in case your services are not acceptable. Similarly, if you decide to terminate this Internship during the Internship period of two months, you are required to give one week's notice.

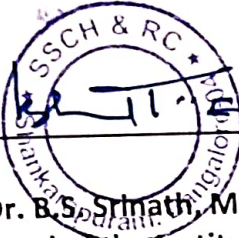

7. You will not be entitled to any benefits or privileges available to the regular employees of the organisation.
8. You shall not indulge in any trade union or other associations related activities.
9. You shall not reveal any confidential information pertaining to either the Institution/Hospital or personal and health information of any patients (OP and IP).
10. You shall not indulge in any kind of discussions with anyone regarding or relating to health condition of the patients, who are being treated at the Hospital. Similarly, you shall not disclose anything about the health condition of the patient to anyone.
11. You shall not treat anyone in the Hospital including the Doctors, other staff members, patients and their attendees discourteously.
12. Management has the sole discretionary power to post you to any other branch / department in the interest of the Organisation.
13. You will work under the supervision of such officers as may be decided upon by the management from time to time. You shall diligently and satisfactorily carry instructions given to you and the best of your power, skill, ability and in furthering the business and interest of the management. You shall not at any time or times, without the consent of the management, disclose, divulge or make public under legal obligations any of the policies processes, accounting transactions and dealings of the Organisation, whether the same may be confirmed or become known to you in the course of your services or otherwise.
