- Provide Information on all the procedure in appealing for a redressal

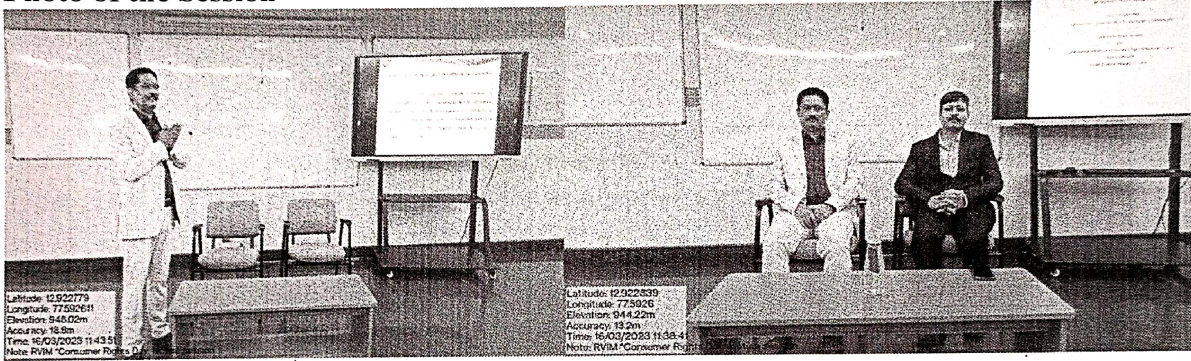
**Agenda/Flow of the Event:**
