Preface:

The Supreme Court in its ruling made it very clear that no BS4 vehicles - including cars, two-wheelers and commercial vehicles will be sold in India after the BS6 deadline comes into play on April 1, 2020. Considering the recent developments in Automobile industry in general and light commercial vehicles in particular, it is important to know the current scenario of BS4 compliant Light commercial vehicles sales before the apex court's deadline comes into play.

Akshara Motors, authorised Dealers of Ashok Leyland Light commercial vehicles approached RVIM tundertake research assignment to analyse the Market Potential for Light Commercial vehicles (LCV) for School segment in Bangalore city. The pilot survey was undertaken for Jayanagar and J P Nagar areas of Bangalore city to develop and test the research instruments and then to carry out the same for pan Bangalore city.

For research purpose, Bangalore city was divided into multiple regions on the basis of PIN codes. 
