# **ADMISSION POLICY**

RV Institute of Management follows the instructions of all the concerned regulatory bodies namely AICTE, State Government and Affiliating University with regard to all the Policies and Procedures.

#### **OBJECTIVES:**

- To ensure the adherence towards total sanctioned intake of students every academic year by the concerned regulatory bodies. Presently, the total sanctioned intake of the institute is 180 students every year. 90 students will be admitted under the Management Quota and 90 Students will be admitted from the Government Quota as per AICTE norms, Bengaluru Central University and Government of Karnataka regulations
- To ensure that all the legal liabilities of the concerned regulatory bodies related to admission of the students are adhered to without any violations throughout the admissions process
- To continuously improve the quality and responsiveness of admissions process
- To ensure fairness and equitable access to the MBA Programme offered to the eligible students by the institute
- To make the admissions process student -friendly as far as possible by taking necessary steps whenever and wherever required
- To empower student applicants to apply online, thereby saving staff and/or student applicant's time and cost

#### **POLICY FRAMEWORK:**

- Admission Committee is constituted to ensure the smooth flow of the entire Admission process/procedure
- The Admission committee will formulate set of required admission policies and procedures to be followed during the admission process of every academic year in consultation with the Director
- Adherence to all the rules and regulations of Admission Criteria such as:-

#### **ELIGIBILITY CRITERIA:**

• Candidates who have secured an aggregate of minimum of 50% marks Bachelor's Degree (10+2+3) from recognized University/ Institute in any discipline

# Selection Process based On Entrance Test Scores, Group Discussion (GD) And Personal Interview (PI):

• The selection process for two year full time MBA Programme offered will be based on the score obtained in PGCET for Government Quota Seats (50% of the sanctioned seats i.e, 90 seats), and based on the score obtained either in MAT/KMAT/CMAT/ATMA for Management Quota Seats (50% of the sanctioned seats i.e, 90 seats), followed by Institutional Aptitude Test, Group Discussion and Personal Interview

### Government Quota

- The students seeking admission through the Government Quota (90 Seats) need to appear for the entrance test known as Post Graduate Common Entrance Test (PGCET) conducted by the Karnataka Examination Authority (KEA)
- The candidates will be allotted seats in respective colleges through centralized counseling conducted by the Karnataka Examination Authority (KEA) based on the ranks secured in the Post Graduate Common Entrance Test (PGCET)

# Management Quota

- The students admitted under the management quota will be first screened from All India Entrance Examination known as MAT (Management Aptitude Test) or any of the approved National level Entrance Test such as K-MAT, CAT, CMAT etc.,
- The students need to produce the prescribed documents and filled-in admission form within the prescribed time to seek admission in the institute and the documents submitted by the students need to be properly verified by the administrative office
