

3. Students will have choice to remit Examination fee through multiple payment modes. Details of the same are given below.
 - a. The Students can pay the Examination fee through **"Payment Gateway"** that is available through the Students Web Portal. Payment of fee through Net-Banking, Credit Card, Debit Card, Wallets, UPI and other means are available through the **"Payment Gateway"**
 - b. The Institute shall communicate students the receipt of Examination fee through digital communication such as SMS / e-mail / Notification, etc;
 - c. Options/choices for payment of Examination fees will be at the discretion of students. Service Charges / Transaction fee varies from ZERO to nominal amount depending on the type of payment option/choice selected by the students and the same will be displayed in the portal when the payment option is selected.
