Functioning of the Governing Body:

Broad functions of the Governing Body include;

- Guide the college while fulfilling the objectives for which the college has been granted autonomous status.
- Institute scholarships, fellowships, studentships, medals, prizes and certificates on the recommendations of the Academic Council
- Approve new programmes of study leading to degrees and/or diplomas.
- Ensure all recruitments of Teaching Faculty/Principal shall be made by the Governing Body as applicable in accordance with the policies laid down by the UGC and State Government from time to time.
- Approve annual budget of the college before submitting the same at the UGC.
- Perform such other functions and institute committees, as may be necessary and deemed fit for the proper development of the college

The Governing Body shall be reconstituted every three years except in the case of UGC nominee who shall have a term of five years. Please note that the Governing Body will be meeting twice in a year and sitting charges to the external members will be paid as per the UGC norms. **We are planning an upcoming first GB meeting sometime in July-August, 2021.** Exact date and time will be communicated well in advance with the detailed agenda. Depending on the situation, meeting will be either physical or virtual.
