The International Conference on Business Intelligence and Data Analytics (BIDA 2024) was organized by RV Institute of Management (RVIM), Bangalore, India and Technically Sponsored by Soft Computing Research Society. It is a prestigious event that brings together professionals, researchers, academics, and industry experts from around the world to discuss and exchange ideas on the latest advancements and innovations in the fields of business intelligence (BI) and data analytics. It provides a platform for networking, collaboration, and learning, enabling participants to stay abreast of emerging trends and best practices in leveraging data for strategic decision-making and business growth.

The conference was well attended by eminent academicians from reputed educational institutions and research scholars from different parts of the country. we received 491 paper submissions across 12 countries namely, Cambodia, Ecuador, Fiji, India, Morocco, Nigeria, Philippines, Russia, Serbia, Sri Lanka, USA, Vietnam, out of which 58 papers were accepted and registered. We also received around 557 reviews. The Acceptance rate being 12%.

Therefore, 58 selected papers were presented in the conference in 11 technical sessions across the 2 days of the conference. The key themes included Advanced Analytics and Machine Learning, Business Intelligence Applications, Big Data Management and Processing, Business Intelligence Applications, Data Governance and Privacy, Industry 4.0 and IoT Analytics, Visual Analytics and Data Visualization and Business Strategy and Data-driven Decision Making

Inauguration of the Conference was done in the presence of Dr. J. C. Bansal, General Secretary SCRS, Dr Srinidhi S, Founder & CEO, Sainik Cars Mobility Innovations Pvt Ltd, Bangalore who was the chief guest, Guest of Honor, Prof. Bholanath Dutta, Founder & President- MTC Global, Prof. Dieu Hack-Polay, Professor in Management, Crandall University, Canada & the University of Lincoln (UK). the importance of innovations and productivity in various fields of business and how innovations can be adopted using common sense approach.

There was Keynote address by Mr. Akilur Rahman, Chief Technology Officer - Hitachi Energy India Limited who spoke about Industry 4.0 and VUCA in Business followed by the 2nd Keynote talk by Dr. Sergio Ribeiro, who is a professor of Management at Crandall University Canada. He spoke about Artificial Narrow Intelligence, General Intelligence and Artificial super Intelligence. The 3rd Keynote address was delivered by Prof. U Dinesh Kumar, IIM, Bangalore, who spoke about "Demystifying AI with use cases from India". Sir talked about the value of data where he gave the example of Amazon's revenue earned through their recommendation system and the Applications of AI in innovation, automation, insights and intelligence.
