Internet Lease Line for our Institutions:

28.06.2021

- M/s Touchous Communication Pvt. Ltd were providing ILL services to our Institutions for more than four years and their services were found to be satisfactory. The company was later taken over by M/s Seans Media Pvt. Ltd.,
- Their current contract is due for renewal from 1st June 2021.
- As we are renewing the contract there is a saving on installation charges as we need routers for each institution.
- Firewall's are also provided by them there by a saving on maintaining our own firewall's in different locations which would cost around ₹. 60,000/- per location.
- Currently we are paying ₹. 6,670/- per Mbps plus GST which they have agreed to revise it to two slabs of ₹.4,800/- and ₹.5,800/- per Mbps per annum plus GST based on the campus wise demand as given in Annexure-1. **There will be a saving of ₹.6,14,700/- plus GST per annum.**
- ISP will bill the individual Institutions directly based on the bandwidth allotted. Billing to be done Quarterly by submitting the necessary usage charts and breakdown details if any.
- ISP to ensure 99% uptime, any deviation they will be liable for penalty as per original order.
- M/s Gurudev Infotech will be coordinating with the ISP and to maintain the network from the point of termination by the ISP. The charges for the same will be ₹. 60,000/- per annum plus GST and they have agreed for the same rates for one more year.
- We may consider placing an order with **M/s Seans Media Pvt. Ltd., 7th floor, Raheja Towers, East Wing, 26/27 M.G Road, Bengaluru- 560 001** for providing Internet connectivity to the Institutions from 1st July 2021 to 30th June 2022. The ISP may be permitted to bill at the existing rates till June-2021.
- **Total current bandwidth (including additional bandwidth for online classes) is around 470 Mbps and the approximate expenditure is around ₹. 25,20,200/- per annum plus GST as applicable.**
- The Institutions are advised to check the proper use of bandwidth and to surrender the additional bandwidth once the normalcy is restored.
