

With reference to the above, I would like to bring to your notice that we had purchased 100 computers with configuration Acer Intel Core i3, 4GB RAM, 1TB in the month of November, 2016; from Gurudev Infotech. These systems are 5.4 years old. We had also purchased 40 desktop computers with the configuration Acer Intel Core i3, 4GB RAM, 1TB in the month of October 2018 from Gurudev Infotech. These systems are 3.6 years old. Since these computers old, they are not compatible with existing technology in terms of speed.

We are facing the following problems with these systems;

- 1. Systems performance is very low in terms of speed.
- 2. As we are authorized test centre for conducting online exams like AIMA-MAT, CAT, SMU, CAG, HAL BITS-PILANI etc but the systems are not supporting such exams.
- 3. As part of new autonomous curriculum we have added IT skills enchancement courses (Basic and Advanced) to all the MBA students irrespective of specialization, where-in we have to train them on Advanced Excel, Power BI & R Programming. The systems speed in not adequate for this purpose.
- 4. To increase the speed of the systems, we need to supplement the HDD with SSD hard disks in these systems.


