About the Event:

Business takes the lead from initiatives spelled out in the budget, and resource allocations made to several focus areas apart from changes to encourage investment and economic activity due to changes in tax rates.

We have identified five focus areas for your consideration.

The Format:

Once you choose your focus area, following your registration for the competition, the organisers will send you a brief write up of the present state of the area of activity (viz Digital Payment etc) . You will have to update and present your business development ideas using the changes made in the Budget Statement.

You may also choose more than one focus area.

Eligibility Criteria:

Interested Undergraduate and Postgraduate students from Commerce, Management and Economics disciplines.

General Regulations:

1. All participants must carry a college ID
2. Participants are required to be in formals (preferred college uniforms)
3. Each participating team is required to send a mail of the presentation at least one day before the event
4. There can be multiple teams from the same institutions. All members of the team should be from the same college.
5. Mode of Participation : Offline / Online (Outstation Participants)
6. The decision of the judge will be final

The winner of each of the five focus areas listed above will receive a **cash award of Rs. 5,000.00 per team**
