

 - V. Feedback of the participants who attend the Workshop.
 - VI. List of Resource Persons along with their designation and contact details (At least 60% Resource Person as mentioned in the proposal must participate in the workshop)
5. Commission shall depute an officer/observer to ensure adherence with the stipulated guidelines and presence of the qualified resource persons. **The Workshop must be conducted within four months from date of receipt of sanction order.**
6. It may also be noted that it may take at least one month to release the first instalment after receipt of the requisite information/documents from you.
7. It is mandatory to submit the requisite documents under Para 3 (II) within 1 month of conducting the seminar or else the sanction amount may be forfeited.

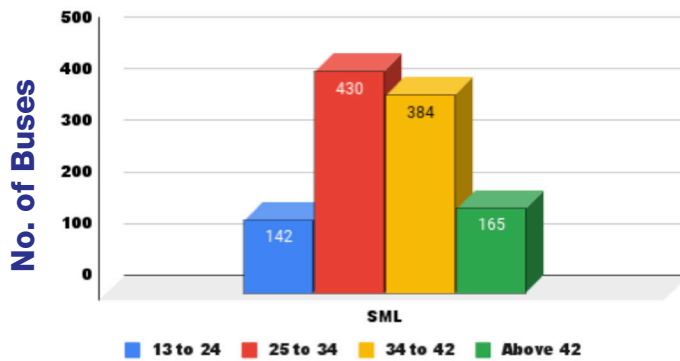


Ashok Leyland vs SEAT

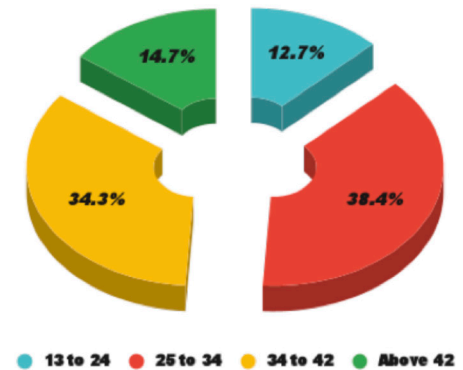

Findings of the Study

1. The Schools affiliated to CBSE are more in number across Bangalore city. Private Unaided schools are second in the list in terms of number of schools amongst the surveyed schools.
2. The total students' strength in Higher Primary and higher secondary section is significantly more as compared to PU section amongst the surveyed schools.
3. 85% of the surveyed schools in Bangalore city cater up to High school section. (std. 1 to std. 10).
4. Amongst the surveyed schools, 447 schools in Bangalore city do not provide any transport facilities to their students. This is attributed to lack of parking space, total admissions, location of the school, socio-economic conditions of the students and proximity.
5. 286 (8.7%) of the total fleet amongst the surveyed schools have Ashok Leyland bus, 1121 (34.1%) have SML, 547 (16.7%) have Tata, 785 (23.9%) have Eicher, 38 (1.2%) have Mahindra and 508 (16%) have other brands of bus.
6. 32% (1121) of the total fleet owned by the School's management held by Swaraj Mazda (SML).
7. Small contractors have deployed more vehicles compared to established fleet operators amongst the surveyed schools. This explores the untapped potential of small and medium fleet operators with respect to business opportunity.
8. 34 – 42 Seats are more deployed followed by 13 -24 Seats and 25 – 34 Seats amongst the surveyed schools.
9. 3 X 2 Layout is the most preferred type amongst the surveyed schools.
10. 49% (76884) of the total new students' admissions is expected at CBSE schools. This implies more students are opting for CBSE schools in Bangalore city.
11. 82% of the schools who own their own fleet amongst the surveyed schools prefer internal financing (cash / management funds / NBFCs) for purchase of bus.
12. 32S is the most preferred seating capacity amongst the surveyed schools.
13. Non A/C bus are preferred more amongst the surveyed schools. This implies that majority of the schools are conservative and aim at cost cutting.
14. 58% of the total prospective buyers amongst surveyed schools are tentatively planning their purchase during April – August, 2023.
15. A demand for 645 units of School bus is anticipated from the surveyed schools.

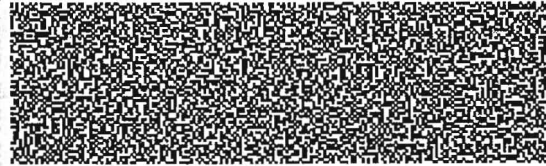
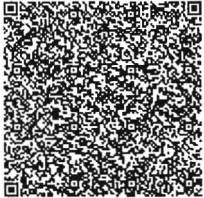

9.4 In the event of (i) any fraud and misrepresentation by **RSST** or (ii) initiation of criminal proceedings against **RSST** or its Trustees/Directors for any reason whatsoever; or (iii) violation of confidentiality obligations by **RSST**; or (iv) violation of any laws of the land by **RSST** or (v) Professional misconduct by **RSST** or (vi) unethical practices by **RSST**, **ABFRJKT** shall terminate the Agreement immediately upon issuance of notice to **RSST**.

10. Consequences of expiry or termination

13. Force Majeure

Either party shall be excused from performance of this Agreement during or to the extent that performance is prevented by the occurrence of unforeseen causes beyond the control of anticipated or unforeseeable by and without the negligence of the party claiming excuse. Such causes include, without limitation, strike, go slow, other concerted acts of workmen, acts of god, war, fire, explosion, action of elements, earthquake, flood, civil disturbance and government restrictions and limitations. The party claiming excuse shall give written notice within 48 hours of the occurrence of such event. If performance is held up for, a continuous period of more than 2 months from the date of first notice, then the two parties shall review the situation and agree upon a course of action so as to protect their interest. A party claiming Force Majeure shall exercise reasonable diligence to seek to overcome the Force Majeure event and to mitigate the efforts thereof on the performance of its obligations under this Agreement.

This consultancy assignment will add to the Institutional branding and will also help us in our NAAC and NBA accreditation process.

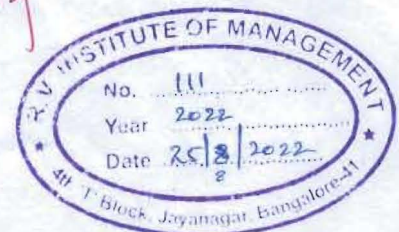
